464. Chairman's Remarks

The Chairman began by reminding Councillors that they had received the Consultation Document: East Lindsey Schedule of Proposed Main Modifications (2017) by email on 8th January 2018 and that the deadline for submissions was 16th February 2017. She wondered if anyone had had chance to determine whether or not the Council would need to make a corporate response. She suggested several courses of action and it was agreed that Councillors should go through the Consultation Document and email any responses that they felt the Council needed to make to the Acting Proper Officer who should collate them and bring them back for ratification on 30th January 2018. The Chairman then stated that notification had been received from ELDC that full planning permission had been granted re. Land west of Keddington House, Keddington Road, Louth for the erection of 10 no. houses in total and associated garages and construction of vehicular access. She reported that this was at variance with the Town Council's own decision to object taken in November on the grounds of volume impact on the local road network, water supply issues, ecology reports being prepared in the winter inactive period and a request for a bat survey.
