The Chairman report that the planning application relating to Land South of Keddington House had been approved by ELDC with 13 conditions.

465. Town Clerk's Report on Matters Outstanding

466. Applications received by the Local Planning Authority.

The Committee considered the applications listed in the schedule (PA/Schedule 02-21-17) and **RESOLVED** as follows:

- **a.** 4) N/105/00151/17 Louth Town Council OBJECT to this application on the grounds of: Loss of car parking which will be required for up to 18 staff members and parents (acknowledged drop off and collect) and could overflow and impact onto on street parking provision. There is also mention of future use of the first floor as offices which will further exacerbate this issue generating more vehicles. Cumulative impact of additional traffic combined with recently approved developments on Eastfield Road. Exiting traffic from this site may also conflict with Emergency Services vehicles from adjacent sites.
- **b.** 7) N/105/02262/16 Whilst Louth Town Council are aware that permission has previously been won on appeal for this site it again OBJECTS to development at this site on the grounds of: Contaminated land. No provision for retaining structures to protect properties from the Quarry bank which has shown signs of deterioration recently. Surface water issues requiring attenuation solutions combined with limited capacity infrastructures.
- **c.** To support all other applications.

468. Proposed Work to Trees

The Committee noted the following proposed works to trees and agreed to leave the decisions to the discretion of the ELDC tree officer:

- a. Knoll House, Stewton Lane
 - i. Fell T1 Pine, T2 Pine, both excessive leaning,
 - ii. Remove large branch T3 Pine (Exempt)
 - iii. Reduce Height to 15m T4 T9 Pine to reduce likelihood of storm damage.
- **b.** 40 Westgate
 - i. Beech spp Fell growing towards / into mature cherry tree.
