## **65.** ELDC Transformation Programme

The Council considered it's response to ELDC following a request for LTC to take on costs for provision of ELDC street lighting in Louth. Following a proposal by Cllr. AL, seconded by Cllr. Mrs. MO it was **RESOLVED** that a letter should be sent to ELDC informing them that because the logistical layout of the sites itemised is too complex and some of them are ELDC sites the Town Council feels that it does not wish to take on the liability for the maintenance.

## 66. Flood Forum

The Council received a short verbal report from attendees of the Flood Forum held 20<sup>th</sup> May 2016 hosted by Victoria Atkins MP. It was felt that the meeting had been useful (the bulk of it being questions from the floor) and that out of it Anglian Water had promised to work together with other authorities more.

## 69. Area Forum

The Council noted that ELDC had arranged 3 Area Forums where the nominated Council representatives would receive a presentation from officers and answer questions regarding the Local Plan.
