# 90. Apologies for Absence

#### 91. Chairman's Remarks

The Chairman informed the Committee that 1) one of the paintings leased to the Museum was to be cleaned; and 2) There had been a break in at the Cemetery, this was to be a future agenda item.

#### 93. Minutes

Following a proposal by Cllr. Mrs. MO, seconded by Cllr. Mrs. SEL it was **RESOLVED** to approve as a correct record the Minutes of the Community Resources Committee meeting held on 22<sup>nd</sup> May 2018.

## 94. Occupation Agreement – St. Aethelheard's Chapel

The Committee noted that the Council would shortly enter into year 5 of its agreement with The Orthodox Christian Church Trust of St. Aethelheard Lincolnshire and that the Tenant had expressed a wish to extend their occupation agreement. Following a proposal by Cllr. Mrs. JMS, seconded by Cllr. Mrs. LHW it was **RESOLVED** that as per the current agreement the Council as landlord should authorise a further occupation agreement for a term of 5 years.

## 95. Rental of Space at Sessions House

The Meeting Closed at 8.22pm.

Cllr. AL declared an interest in this item.

The Committee noted that the Council was in year 2 of its 2 year agreement with LNALS (ending 31<sup>st</sup> May 2019) and as per agreed terms the Committee should review arrangements and consider agreeing an extended date. Following a proposal by Cllr. Mrs. JMS, seconded by Cllr. DT it was **RESOLVED** to authorise an extension at the current terms of £15 rent per month over a term of 2 years with a review thereafter and a 3 month notice clause on either side.

#### 96. Cemetery Lodge

The Chairman asked Councillors for a steer on the direction that research should take with regard to the above. The general consensus was to restore. It was agreed that the Chairman would investigate the cost to update existing, but out of date, structural reports which he would report back on.
