It was **RESOLVED** to support the following tree work:

- **a.** Location: 2 Horncastle Road. Proposal: T27 (T1 on plan) and T29 (T2 on plan) Limes. Removal of all epicormic growth from stems and base up to a height of 6m, leaving the growth on the pollarded heads. Reasons: To allow more light into the garden and house windows.
- **b.** Location: 5 George Street. Proposal: T1 Lilac Fell. Reasons: Decayed bases on some stems, gutters getting blocked and minor cracks within retaining wall between properties.
- c. Location: Holly Cottage, 8 Somersby Court. Proposal: T1 English Yew To remove to ground level. Reasons: Small garden; tree blocks light to house and adjacent properties.

- **d.** Location: 18 Commercial Road. Proposal: T1 English Yew Remove to ground level. Reasons: Small garden; tree blocks light to house and adjacent properties.
- e. Location: 22 St. Mary's Lane. Proposal: A1 Ash, Beech, Birch, Cedar, Chestnut, Elm, Fir, Oak, Sycamore T1 and T2 on plan (Laurel) reduce lateral spread into garden of No.3 by 3m. Reduce height by 3m and reshape accordingly. T2 on plan (Cupressus) approx. 8m high protruding above Laurel by 3-4; top in line with crown of Laurels. Reasons: Trees encroaching into property and significantly reducing light and hindering plant and shrub growth underneath.
- f. Location: Elm Lodge, 57 Cowtree Lane. **Proposal:** A6 Several Ash, Beech, Chestnut, Oak and Sycamore trees (Chestnut marked on plan) lift canopy to 3.5m agl where it overhangs No.5 by removing 1no. limb at c2.5m agl back to the main branch with a c75mm pruning cut. Balance remaining canopy over garden with final cuts no larger than 30mm. **Reasons:** None supplied.

### P18. NHS Update

As a member of Health Scrutiny, Cllr. Mrs. JMS was able to provide an update on possible changes to services at hospitals in Grimsby and Scunthorpe. She explained that it is currently being decided whether Grimsby or Scunthorpe should be considered the main hospital South of the Humber. She was concerned about the issues that would be created for Louth residents if Scunthorpe was chosen, particularly in relation to maternity as it might mean women in Louth would have to go to Lincoln to have their children. Cllr. Mrs. JMS said that she would keep the Council informed on the situation.

### **East Lindsey District Council**

**THIS IS A FORMAL NOTICE** to let you know that the East Lindsey District Council (hereinafter called 'the Council') in pursuance of the powers conferred in that behalf by Section 198 of the Town and Country Planning Act 1990 has made a Tree Preservation Order, a copy of which is enclosed.

The said Order takes effect provisionally from 22nd June 2023 and shall remain in force until either a period ending 6 months from the date of the Order or indefinitely if it is confirmed by the Council.

The grounds on which the Council has made the Order are that the tree affected by this Order is under threat of removal or harmful works and is of significant amenity value, making a valuable contribution to the character of the local area. It is therefore considered expedient in the interests of amenity that a Tree Preservation Order is made to protect the tree(s). The effect of the Order is (subject to certain exemptions), to prohibit, except with the consent of the Council, the cutting down, topping, lopping, uprooting, wilful damage or wilful destruction of the tree(s) subject of, and identified in the Order.



In simple terms, this Order prohibits the cutting down, topping, lopping or uprooting without permission any of the trees described in the Schedule of the Order and shown on the map.

People affected by the Order have a right to object or make comments on any of the trees or woodlands covered before we decide whether the Order should be made permanent.

If you would like to make any objections, expressions of support or other comments please make sure we receive them in writing by 3rd August 2023, but please note that the Council cannot enter into correspondence on any matters raised. Your comments must meet regulation 6 of the Town and Country Planning (Tree Preservation)(England) Regulations 2012, a copy of which is attached.

Please send your comments to Colin Horton, Arboricultural Officer, Neighbourhoods Team, East Lindsey District Council, The Hub & Willow House, Mareham Road, Horncastle, LN9 6PH, or email them to <a href="mailto:trees@e-lindsey.gov.uk">trees@e-lindsey.gov.uk</a>. We will carefully consider any objections and comments before deciding whether to make the Order permanent. I can further advise that a copy of the Tree Preservation Order is available for inspection at the East Lindsey District Council Offices at Horncastle (see address above) during normal opening hours from Monday to Friday.

### **TOWN AND COUNTRY PLANNING ACT 1990**

### The Louth 2023 (105.34) Tree Preservation Order

The East Lindsey District Council, in exercise of the powers conferred on them by section 198 of the Town and Country Planning Act 1990 make the following Order—

### Citation

1. This Order may be cited as the Louth 2023 (105.34) Tree Preservation Order.

### Interpretation

- 2.— (1) In this Order "the authority" means the East Lindsey District Council
- (2) In this Order any reference to a numbered section is a reference to the section so numbered in the Town and Country Planning Act 1990 and any reference to a numbered regulation is a reference to the regulation so numbered in the Town and Country Planning (Tree Preservation)(England) Regulations 2012.

### **Effect**

- **3.** (1) Subject to article 4, this Order takes effect provisionally on the date on which it is made.
- (2) Without prejudice to subsection (7) of section 198 (power to make tree preservation orders) or subsection (1) of section 200 (tree preservation orders: Forestry Commissioners) and, subject to the exceptions in regulation 14, no person shall—
  - (a) cut down, top, lop, uproot, wilfully damage, or wilfully destroy; or
  - (b) cause or permit the cutting down, topping, lopping, uprooting, wilful damage or wilful destruction of,

any tree specified in the Schedule to this Order except with the written consent of the authority in accordance with regulations 16 and 17, or of the Secretary of State in accordance with regulation 23, and, where such consent is given subject to conditions, in accordance with those conditions.

### Application to trees to be planted pursuant to a condition

**4.** In relation to any tree identified in the first column of the Schedule by the letter "C", being a tree to be planted pursuant to a condition imposed under paragraph (a) of section 197 (planning permission to include appropriate provision for preservation and planting of trees), this Order takes effect as from the time when the tree is planted.







### MINUTES OF THE LOUTH TOWN COUNCIL COMMUNITY RESOURCES COMMITTEE HELD IN THE OLD COURT ROOM, THE SESSIONS HOUSE, LOUTH ON TUESDAY 23<sup>RD</sup> MAY 2023

The Town Clerk, Mrs. L.M. Phillips, the Town Clerk's Assistant, Miss S. Chitauro, Mr. J. Timson, Sergeant K. Palmer and 5 members of the public were also present.

Members of the public spoke in the public forum as follows:

- A lady proposed that the Charles Street Recreation Ground be used as a community initiative to develop green spaces, aiming to improve the mental health and wellbeing of the community. She stated that it would be beneficial to work with local business to maintain all green spaces in Louth, such as the tennis courts and croquet area.
- A second lady enquired about the fishing pond at the Charles Street Recreation ground. She stated that the pond is fenced off, but people easily get into the area, which makes her upset for the fishermen who use the pond. She was interested to know who is responsible for the space, who currently looks after the area and the possible future for the area.
- Andrew Leonard, District Councillor for the Ward in which Charles Street Recreation Ground is located in, stated that he thought the financial cost and liability involved with the Charles Street Recreation Ground would be too high. He was concerned about the anti-social behaviour taking place in the grounds over the years and did not believe that the Town Council had the manpower to make owning the Recreation Ground work.

### C1. Election of Community Resources Committee Chairman

It was RESOLVED that Cllr. DH be elected as Chairman. Cllr. DH took the Chair.

### C2. Election of Community Resources Committee Vice Chairman

It was **RESOLVED** that Cllr. LMC be elected as Vice Chairman.

### C3. Apologies for Absence

Apologies for absence were received from Cllr. PS.

### C4. Declarations of Interest / Dispensations

a. Cllrs. Mrs JMS, GEH and DH – agenda item 8 – as members of ELDC.

### C5. Minutes

It was **RESOLVED** that the notes of the Community Resources Committee Meeting held on 4<sup>th</sup> April 2023 be approved as the Minutes.

### C6. Louth Police

Sgt. Palmer reported that the number of PCSO's in Lincolnshire is to be reduced by 40 by October, which will leave Louth with two PCSO's, one sergeant and two beat managers by this time. This is due to the Vulnerability Locator Index which is used to place PCSO's and which takes criteria such as free school meals and criminality rates into account. She opined that whilst two seems like a low number of PCSO's, it is good compared to other areas. Councillors asked if there was anything the Council could do to help the police. Sgt. Palmer confirmed that lobbying the PCC was all LTC could do and reporting all instances of crime would be very beneficial if the public could be encouraged to do that. She said that lobbying ultimately leads the police to spend money where the community want it and community engagement funding is based on how much crime is reported. She urged people to report crimes by calling 999 and 101 and reach out over social media or email.

### C7. Presentation by Mr. J. Timson

Mr. Timson gave an update regarding the planning application for a 3G astroturf pitch proposed for Wood Lane. He confirmed that ELDC had withdrawn the original application but that he fully expected they would reapply. He reported that the CEO of Lincolnshire Gateways Academy had told him that ELDC had not consulted with them properly about the possibility of placing the 3G on the Cordeaux field and he was hopeful that talks between them might also take place. He reported that his intention, if ELDC reapply on the Wood Lane site is to vehemently oppose the application. He was to set up a Green Space group which would protect and improve green spaces in the town and would have a budget to provide new equipment and undertake some maintenance. His dream was for that group to become a registered charity not just a fundraiser.

### **C8.** Charles Street Recreation Ground

A lengthy discussion took place about the future of the Recreation Ground. Council felt, at that stage, it was a wider issue and was not just about it taking ownership. It was **RESOLVED** that Louth Town Council should enter into discussions with ELDC about bringing the Recreation Ground back into recreational use.

### C9. Hedgehog Highway Project

Following discussions about the Hedgehog Highway Project, it was **RESOLVED** that Louth Town Council would liaise with the Lincolnshire Wildlife Trust about the sustainability of the project before moving forward with it.

### C10. Coronation of King Charles III

After considering the time passed since the Coronation of King Charles III and the cost of the planter, it was **RESOLVED** not to proceed with plans to acquire a metal decorative planter to commemorate the Coronation of King Charles III.

### C11. Working Group

It was **RESOLVED** that the Asset Working Group be re-established, its remit to remain unchanged and its membership to be as follows: Cllrs LF, DH (Chair CR), GH, MB, LMC, HF, JMS, JS, ML.

### C12. Next Meeting

It was noted that the next scheduled meeting of the Community Resources Committee would take place on 11<sup>th</sup> July 2023.

### **CCTV REPORT**

### History:

1997 – CCTV for Louth was first mooted by Inspector Rod Bell and Sergeant Mike Knaggs. The Town Council agreed to give financial support as did many Louth businesses. Cameras were located around the center of the town, strategically placed to 'oversee' each other. A committee consisting of town councillors, police and local volunteers was set up to oversee the running of the system. Volunteers manned the control room day and night, especially at weekends. Regardless of the availability of the volunteers recordings were made from each camera, for evidential purposes. ELDC had also installed cameras on Louth Industrial Estate, which were monitored in the towns control room.

After several years and, at the suggestion of ELDC, who greatly assisted with the funding, the five 'CCTV' towns within East Lindsey, joined forces with a central control room situated in the Police Station at Skegness. Paid operatives were now able to be employed to oversee the control room every day and night. The group, with the addition of an ELDC councillor and officer met regularly under the banner of East Lindsey CCTV Partnership. It continues to this day.

After yet a few more years the control room moved to Boston where fully trained operatives monitor cameras for South Holland District Council, East Lindsey District Council and North Kesteven District Council as well as Boston and Kirton. The operators oversee some 200 cameras with the system operational 24 hours a day, 365 days a year.

Installation of a review suite at Mablethorpe Police Station is now underway.

### Louth:

As with the other towns within the system the cameras and equipment are regularly upgraded with the ever-increasing use of new technology. The town council pays on a pro rata basis for the maintenance of its cameras and any additional cameras that the town may need. A new camera is about to be installed covering the Northgate area, at the request of the Police. ELDC funds everything else involved with the running of the system.

Jonathan Challen, ELDC officer, was asked if an ANPR camera could be reinstalled on the Fish Shambles. Mr. Challen confirmed that while there had once been such a camera in this position it had merely shared the power source of an existing CCTV camera and that it was nothing to do with the CCTV partnership. It had been a Police/LCC matter. Eight or nine years ago such camera locations had been changed.

Mr. Challen was also asked if the report from the Police that the CCTV cameras on the Industrial Estate were not working was true. Mr. Challen said this was not true. ELDC were having to rationalize camera positions with the Information Commissioners Office and, to meet regulations were having to be careful that they were not breaking the law and so at present cameras were only trained on the entrances and exists to the Industrial Estate while details of other locations were finalised with the ICO. However, he confirmed that ELDC were keen to maintain a presence in the area.

The CCTV service has recently undergone scrutiny, with the ELDC Scrutiny Board stating that it was pleased with everything. ELDC, BBC and the SH partnership held an annual awards ceremony at which the CCTV team won the 'Going The Extra Mile' award.

The meetings of the ELDC partnership continue to be as useful as they were when they first started many years ago, with representatives from Louth, Alford, Horncastle, Mablethorpe and Sutton on Sea, Chapel St Leonards, Ingoldmells and Skegness making sure that our towns are monitored every day of the year with the most up to date equipment and expertise.
