

### Report to Louth Town Council from The Hubbard's Hills Trust 19<sup>th</sup> September 2023

The Hubbard's Hills Trust respectfully request that an amount of £49,000 plus the annual increment of CPI be included within the Town Council budget for payment to the Trust, in two instalments in 2024/25.

The full set of accounts that will be presented to LTC is imminent and awaits final approval from the next trust board meeting. This has been delayed due to waiting for the final account to be received in respect of the riverbank work etc. In anticipation of this invoice we expect that it will reduce our bank balance to a nominal figure of about ten thousand pounds. It could be even less than that figure. Therefore, the projected spend will as previously be within the bounds of our existing budget constraints, until we accrue a small surplus of reserve capital for project expenditure.

In respect of a business plan the objective would be financially to catch our breath and see how this next year pans out. The continual vandalism eats away at our yearly allowance any future shortfall may need to be requested from LTC as per the contractual agreement. Other priorities now include the removal of diseased trees as outlined within our last report.

The Committee considered all planning applications received, including those listed in the schedule (PA/Schedule 08-29-23) and **RESOLVED** as follows:

- **a.** N/105/01376/23 Louth Town Council originally objected to this application on 8th August 2023 and after further consideration on 29th August 2023 objected again on the grounds that the proposals were overbearing in terms of height, being much taller than neighbouring properties. As the site is in the conservation area this will have a detrimental effect on the conservation area in general and surrounding listed buildings, negatively impacting the skyline and the view of St. James' Church from the Old Cemetery, resulting in the loss of public visual amenity.
- **b.** N/105/01539/23 To object to this application on the grounds of traffic generation, access and highway safety.
- c. N/105/01646/23 To object to this application on the grounds that the proposed dwelling is overbearing in terms of height and size and it is sited too close to other residential boundaries. Therefore, it will overshadow its neighbours and harm their amenities. The location of the proposed access, being in close proximity to 180b Eastgate, will also have an adverse impact on that property's residents.
- **d.** N/105/00925/23 To object to this application on the grounds that the proposals are overbearing for the size of the site. The Council were concerned about the layout and density of buildings and felt that the egress was dangerous, having a very poor visual splay due to the line of parked cars, always present, on the side of Upgate and effectively making a double crossroads on Upgate, being located opposite Quarryside and next to an existing extremely busy traffic light controlled crossroads.
