# c. Planning Appeal

i. N/105/00635/17 Land at Cistercian Cottage, Stewton Lane – to be determined on the basis of written representations. LTC supported this application, additional / modified comments must be received by 17/10/2017. Following a proposal by Cllr. AL, seconded by Cllr. RJ it was RESOLVED that a letter of support should be sent stating

that the site is not in open countryside but is within the envelope of the town and so should be permitted.

# 292. Proposed Works to Trees

The Committee considered the following proposed works to trees and made no comments:

- **a.** 76 Kenwick Road (TPO) T5 Lime thin crown, remove shoots, remove deadwood, reduce crown height to 18m height and 5m spread. Tree is overhanging onto neighbours property and deadwood on tree.
- **b.** 24 St Mary's Park (TPO)– G5 3 Lime, 2 Sycamore, 1 Read Oak, 1 Common Ash 1 No Lime and Red Oak Crown Lift to 5m to allow more light into the garden and bring in line with the 2 neighbours trees.
- **c.** 36 Bridge Street (Conservation Area) T1 Sycamore, T2 Lime spp and T3 Lime spp reduce southern side of crowns from 6m to 4m, to stop interference with the property.
