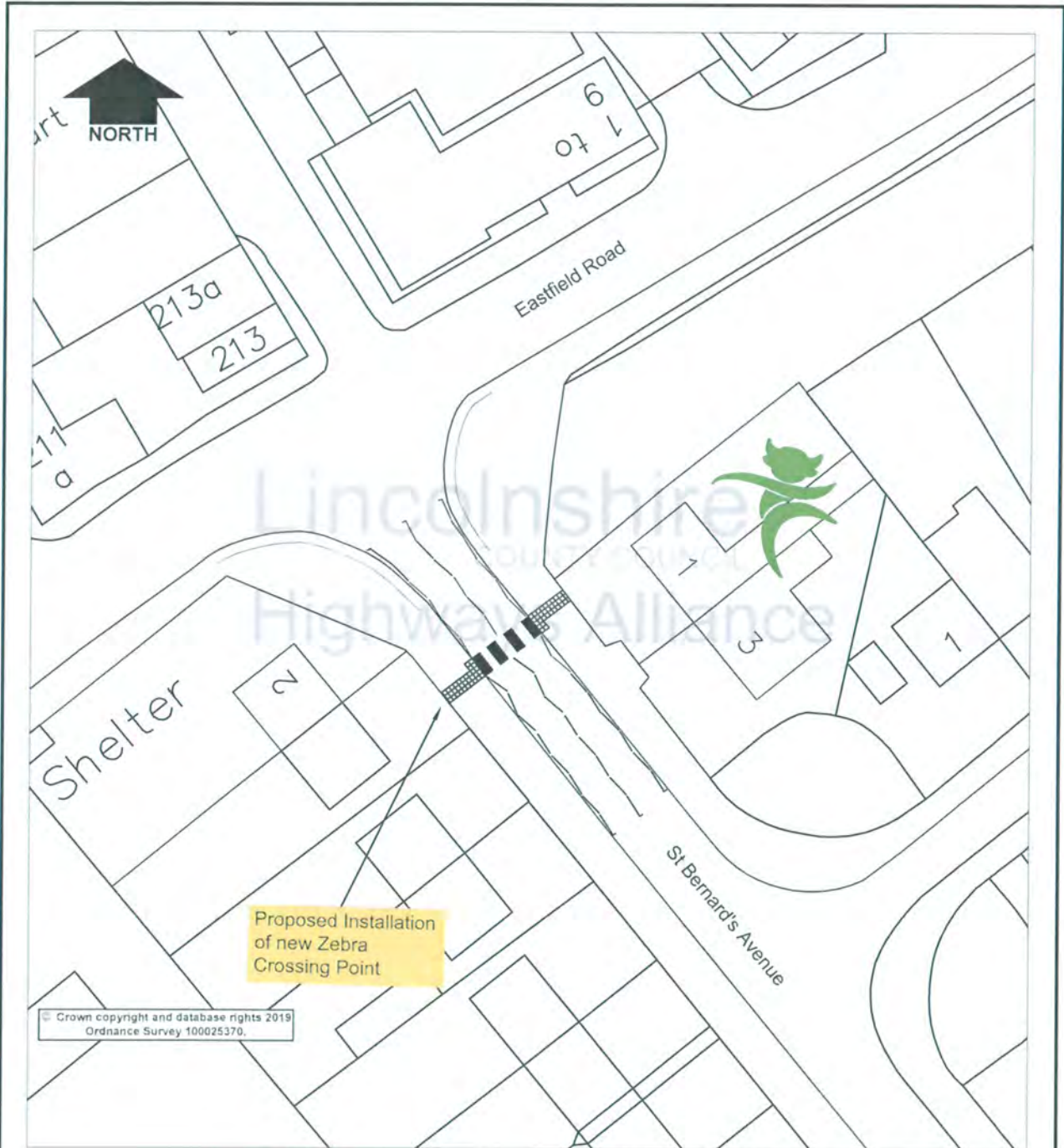
A plan showing the location of the proposed Zebra Crossing is attached (Drawing number H/JE/LTC/001) along with a copy of the site notice.
