T37. Apologies for Absence

Apologies for absence were received from Cllrs. PS and DEW.

T38. Declarations of Interest / Dispensations

T39. Minutes

It was proposed, seconded and **RESOLVED** that the notes of the Council Meetings held on 8th April 2025 and 3rd June 2025 be approved as the minutes.

T40. Annual Governance and Accountability Return (AGAR) 2024/25

On the recommendation of FOG:

- a. The Council received the report from the internal auditor and noted that no actions were required.
- b. The Council received the Statutory Balance Sheet for the year ended 31st March 2025 and approved it for signing by the Chairman and Responsible Financial Officer.
- c. The Council approved the completion of the Annual Governance Statement (Section 1 of the AGAR) for the financial year 2024/25, placing ticks against 'Yes' in all boxes except number 9 where n/a should be ticked and approved signing by the Chairman and Town Clerk.

The Council considered its stance on devolution and its potential effect on the future of the Town Council. After review, it was proposed, seconded and **RESOLVED** to proceed with all the work quoted, with funds to be taken out of EMR Capital Expenditure and the Town Clerk granted delegated authority to progress.

While in closed session the Town Clerk asked if she might update members on proceedings in relation to a) Old Mill House and b) The Astro Turf Lease at London Road as there had been movement since the agenda had been sent out and she wished to ensure Councillors were happy with proceedings. She asked members to confirm the course they wished her to follow when dealing with these two issues (to be ratified at the next meeting) which were as follows: a) The Council noted the lease holders right to buy (previously confirmed by the Barrister), risk of court proceedings and the potential financial burden that that might bring. They received the Barrister's Advice and agreed that as there was no cast iron option to retain the property, and the financial risks of trying to do so were too great, the Council had no choice but to proceed with sale of the freehold (according to legislation) at the value previously calculated by the District Valuer. b) The Council noted the changes proposed by the LRSP's solicitor to the draft lease and believed none should be implemented.

At 9.11pm it was proposed, seconded and **RESOLVED** to move out of closed session.

REPORT OF THE PARK AVENUE PLAYGROUND WORKING GROUP (PAPWG)

The working group was set up to investigate a request by the Park Avenue Residents Group (PARG) for support and financial assistance following communication between themselves and Gleeson homes limited regarding the possible gifting of a former play area behind the shops on park avenue.

Following on from this request the Louth Town Council PAPWG had a site visit to familiarise themselves with the site and to confirm the amount of proposed land being gifted.

It was then followed up by a Teams meeting between the groups in which Mr Mick Rawlinson Land Director Gleeson Homes confirmed that they would like to transfer ownership to either the PARG or Louth Town Council, with PARG confirming that their preferred option was that Louth Town Council take ownership and rent it back to them for a peppercorn rent.

A meeting was set up at the Park Avenue Youth Centre between PAPWG and PARG where a range of options were discussed, with Councillor Karen Parsons strongly advising that PARG set up as a charity, this view was endorsed by PAPWG, however it was advised that they should still proceed with their funding application whilst awaiting charity status.

A site visit was arranged to the Theddlethorpe play area where we met parish representatives who talked us through their experience of running the park and any problems and local benefits it had brought.

The Residents group have approached Saul Farrell from the Local Growth and Grant Funding Group South and East Lincolnshire Councils Partnership enquiring into an application for £90,000, with future support from Louth Town Council and other funding groups.

PAPWG RECOMMENDATIONS

- 1. Louth is extremely poorly served with Children's play areas and we would support PARG's application for funding through the Local Growth and Grant funding Group South and East Lincolnshire Councils Partnership enquiring into an application for £90,000 with future support from Louth Town Council and other funding groups.
- 2. It was proposed, seconded and resolved after a recorded vote that Louth Town Council should secure the site and ownership of the land, contingent on the establishment of a community group who would undertake the day to day running of the land. The PAPWG recommend that the community group must gain Charitable status before this can be considered as it feels that would best serve not only the governance and fundraising abilities but would also give local ownership and a sense of community pride.

Community Communications (A voice for the community of Louth)

A question was raised at the 2025 Annual Town meeting re central communication and would LTC seek a solution.

Across all parts of our community, often people say a similar thing..... that they don't know what is going on in the town and that if there is a need, they don't know who to turn to for help.

A community communication could go some way to appease these needs and bridge some of the gaps.

Delivered to every household. Currently around 8100, plus some spares for LTC, businesses and local tourist info spots for example museum, theatre and churches.

Several of our neighbouring towns, have community communications, they not only use Facebook and other forms of social media to inform their communities, but they also have magazines.

All the magazines researched have similar content, 100% focused on being the voice of the community and does not include editorial such as Ball/dance, wedding, prom photos, sports club scores etc.

A place Map, Business Advertising, Town Council information including Councillor contacts, information on services, a directory of local contacts for community groups, Directory of useful contacts (such as Drs, Dentist, Food banks, leisure facilities) What's On calendar, Editorial from key organisations.

Some examples:

Mablethorpe and Sutton have a Town Guide, an A5 magazine, printed annually, delivered to all households. Pulled together principally by the Clerk and Councillors. Content is mostly about facilities available in the towns.

Horncastle Matters, An A4 magazine, printed quarterly, delivered to every household. This is drawn together by a team at the Parish Office and is a combination of local news and up and coming events. This is funded through the church, advertising and local grants such as Coop, district councillors, wellbeing fund. Distribution, 4500, is by young people, paid to deliver. Printing is done out of county. Size of publication is as required and not based on the number of adverts sold.

Woodhall Wapentake, A4 magazine, printed monthly. Pulled together by a third party, TUCANN, delivered to every household, and is a combination of local news and up and coming events. Paid for by advertising. Tucann also arrange distribution.

The Town Guide and Horncastle Matters examples would be more reliant on LTC to draw together information and prepare for print.

Initial conversations with some local organisations have been positive, and a general consensus is that something is needed.

Regardless of the editing, at least to begin with, if such a community communication is to be successful then all Councillors would be asked to disseminate across contacts the idea of a community communication and how the community could get involved.

Proposal

For Councillors to:

consider if they wish for Louth to have a new magazine

- If the answer is yes, how frequently do Cllrs. feel they would like print, annually, quarterly or monthly
- To consider the method by which a magazine is pulled together, internally or externally
- to agree for working group to undertake further research with Town clerk the preferred route to having a community magazine in print.

EQUALITY AND DIVERSITY POLICY

Our commitment

Louth Town Council is committed to providing equal opportunities in employment and to avoiding unlawful discrimination.

This policy is intended to assist the council to put this commitment into practice. Compliance with this policy should also ensure that employees do not commit unlawful acts of discrimination.

Striving to ensure that the work environment is free of harassment and bullying and that everyone is treated with dignity and respect is an important aspect of ensuring equal opportunities in employment.

The law

It is unlawful to discriminate directly or indirectly in recruitment or employment because of age, disability, sex, gender reassignment, pregnancy, maternity, race (which includes colour, nationality, caste and ethnic or national origins), sexual orientation, religion or belief, or because someone is married or in a civil partnership. These are known as "protected characteristics".

Discrimination after employment may also be unlawful, e.g. refusing to give a reference for a reason related to one of the protected characteristics.

Louth Town Council will not discriminate against or harass a member of the public in the provision of services or goods. It is unlawful to fail to make reasonable adjustments to overcome barriers to using services caused by disability. The duty to make reasonable adjustments includes the removal, adaptation or alteration of physical features, if the physical features make it impossible or unreasonably difficult for disabled people to make use of services. In addition, service providers have an obligation to think ahead and address any barriers that may impede disabled people from accessing a service.

Types of unlawful discrimination

<u>Direct discrimination</u> is where a person is treated less favourably than another because of a protected characteristic.

In limited circumstances, employers can directly discriminate against an individual for a reason related to any of the protected characteristics where there is an occupational requirement. The occupational requirement must be crucial to the post and a proportionate means of achieving a legitimate aim.

<u>Indirect discrimination</u> is where a provision, criterion or practice is applied that is discriminatory in relation to individuals who have a relevant protected characteristic such that it would be to the detriment of people who share that protected characteristic compared with people who do not, and it cannot be shown to be a proportionate means of achieving a legitimate aim.

<u>Harassment</u> is where there is unwanted conduct, related to one of the protected characteristics (other than marriage and civil partnership, and pregnancy and maternity) that has the purpose or effect of violating a person's dignity; or creating an intimidating, hostile, degrading, humiliating or offensive environment. It does not matter whether or not this effect was intended by the person responsible for the conduct.

<u>Associative discrimination</u> is where an individual is directly discriminated against or harassed for association with another individual who has a protected characteristic.

<u>Perceptive discrimination</u> is where an individual is directly discriminated against or harassed based on a perception that they have a particular protected characteristic when they don't, in fact, have that protected characteristic.

<u>Third-party harassment</u> occurs where an employee is harassed and the harassment is related to a protected characteristic, by third parties.

<u>Victimisation</u> occurs where an employee is subjected to a detriment, such as being denied a training opportunity or a promotion because they made or supported a complaint or raised a grievance under the Equality Act 2010, or because they are suspected of doing so. However, an employee is not protected from victimisation if they acted maliciously or made or supported an untrue complaint.

Failure to make reasonable adjustments is where a physical feature or a provision, criterion or practice puts a disabled person at a substantial disadvantage compared with someone who does not have that protected characteristic and the employer has failed to make reasonable adjustments to enable the disabled person to overcome the disadvantage.

Equal opportunities in employment

The council will avoid unlawful discrimination in all aspects of employment including recruitment, promotion, opportunities for training, pay and benefits, discipline and selection for redundancy.

Recruitment

Person and job specifications will be limited to those requirements that are necessary for the effective performance of the job. Candidates for employment or promotion will be assessed objectively against the requirements for the job, taking account of any reasonable adjustments that may be required for candidates with a disability. Disability and personal or home commitments will not form the basis of employment decisions except where necessary.

Working practices

The council will consider any possible indirectly discriminatory effect of its standard working practices, including the number of hours to be worked, the times at which these are to be worked and the place at which work is to be done, when considering requests for variations to these standard working practices and will refuse such requests only if the council considers it has good reasons, unrelated to any protected characteristic, for doing so. The council will comply with its obligations in relation to statutory requests for contract variations. The council will also make reasonable adjustments to its standard working practices to overcome barriers caused by disability.

Equal opportunities monitoring

The council will monitor the ethnic, sex/gender and age composition of the existing workforce and of applicants for jobs (including promotion), and the number of people with disabilities within these groups and will consider and take any appropriate action to address any problems that may be identified as a result of the monitoring process.

The council treats personal data collected for reviewing equality and diversity in accordance with the data protection policy. Information about how data is used and the basis for processing is provided in the council's privacy notices.

Dignity at work

The council has a separate dignity at work policy and sexual and general harassment policy concerning issues of bullying and harassment on any ground, and how complaints of this type will be dealt with.

People not employed by the council

Louth Town Council will not discriminate unlawfully against those using or seeking to use the services provided by the council.

You should report any bullying or harassment by suppliers, visitors or others to the council who will take appropriate action.

Training and prevention

The council will raise awareness of equal opportunities to those likely to be involved in recruitment or other decision making where equal opportunities issues are likely to arise and with all staff engaged to work at the council to help them understand their rights and responsibilities under the dignity at work policy and what they can do to help create a working environment free of bullying and harassment. It will take active steps to try to prevent third-party harassment of staff. If any third-party harassment of staff occurs, it will take steps to remedy any complaints and to prevent it happening again. Action may include warning the harasser about their behaviour, banning them from our premises, reporting any criminal acts to the police, and sharing information with other branches of the business.

Responsibilities

All employees and councillors are required to assist the council to meet its commitment to provide equal opportunities in employment and avoid unlawful discrimination.

Grievances

If you consider that you may have been unlawfully discriminated against, you should use the council's grievance procedure to make a complaint. If your complaint involves bullying or harassment, the grievance procedure is modified as set out in the dignity at work policy or sexual and general harassment policy.

Louth Town Council will take any complaint seriously and will seek to resolve any grievance that it upholds. You will not be penalised for raising a grievance, even if your grievance is not upheld, unless your complaint is both untrue and made in bad faith.

Monitoring and review

This policy will be monitored periodically by the council to judge its effectiveness and will be updated in accordance with changes in the law.

Information provided by job applicants and employees for monitoring purposes will be used only for these purposes and will be dealt with in accordance with relevant data protection legislation.

This is a non-contractual procedure which will be reviewed from time to time.

The finances were £6k to the good and the surplus money will be going into staff costs.




It was also reported that funding for Neighbourhood Plans had been pulled. There was a suggestion MPs should be contacted about this.

Why change is needed

Greater Lincolnshire is a region rich in heritage, natural beauty, and economic potential. From the industrial towns on the Humber to the market towns and coastal communities, this is a "place of places" – proud, diverse and full of potential.

But our system of local government no longer reflects the needs or identity of the people who live here. Services are delivered by ten different councils, creating duplication, inefficiency and confusion. Residents are often unclear who is responsible for what. Businesses and public service partners face unnecessary bureaucracy. And Greater Lincolnshire's voice is diluted on the national stage.

This is the moment to simplify, strengthen and modernise local government in Greater Lincolnshire.


Two New Councils

We are proposing the creation of two new unitary councils to replace the current system:

Northern Lincolnshire Council, covering Lincoln, North Lincolnshire, North East Lincolnshire and West Lindsey

Southern Lincolnshire Council, covering Boston, East Lindsey, South Holland, North Kesteven and South Kesteven

This is not one-size-fits-all. Northern Lincolnshire looks naturally to the Humber and the Northern Powerhouse. Southern Lincolnshire connects into the East Midlands and East Anglia. The proposed model reflects these patterns of identity, economy and travel.



By aligning with how people live and work, the new councils will be more relevant, more trusted and more effective.

Each council would be responsible for all local services in its area – from roads and housing to education and waste. This single-tier model would end the current split between district and county councils.

Both new councils would be of a similar population and economic size, ensuring fairness between the north and south and providing the scale needed to manage services effectively and sustainably.

Better Services, Closer to Home

The new model will enable smarter, more joined-up services, delivered closer to communities.

High quality adult and children's social care services will be accessible to all residents. The new Councils will improve consistency, raise standards and ensure that the most vulnerable residents receive the care they need, wherever they live.

Each council will maintain local hubs and access points so that services remain visible and responsive. At the same time, new structures will support strategic improvements in housing, planning, transport and community safety – helping councils plan for the long term and tackle the big challenges facing our area.

Value for Money

The reorganisation will remove unnecessary overheads and duplication, freeing up resources to invest in frontline services. It will also create opportunities to reform outdated funding models and make better use of public assets. The South & East Lincolnshire Councils Partnership – covering Boston, East Lindsey and South Holland – has already shown what's possible, with projected savings of £42 million over ten years. This proposal builds on that success and takes it further.

By pooling expertise and removing administrative barriers, the new councils will deliver more for less – and ensure every pound works harder for the people of Lincolnshire.

A Stronger Local Voice

As unitary authorities, both new councils will become full members of the proposed Mayoral County Combined Authority – with equal representation and a direct say over regional investment, devolution and economic growth.

This model gives Greater Lincolnshire a stronger national voice while preserving local character and control. Decisions about local priorities will be made locally – with enhanced roles for town and parish councils, formal area committees, and a clear commitment to community engagement.

A Platform for the Future

This proposal is about more than just structure. It is a platform for ambition – enabling Greater Lincolnshire to grow, innovate and thrive.

It supports our 2050 Vision for a greener, fairer and more prosperous future. It will help us invest in skills, decarbonise our economy, and support residents of all ages to live well.

Now is the time to embrace change – to create local government that is simpler, stronger and more sustainable. Together, we can deliver A Greater Lincolnshire for all.

We recognise that change can be unsettling, particularly on something as important as moving to a new system of local government - that many tens of thousands of people rely upon each day.

The Great Grid Upgrade: Grimsby to Walpole Stage 2

Below are the notes of the Grimsby to Walpole - Grid Upgrade Zoom meeting and Draft Corporate Response.

Guest: Andy Roberts

Andy Roberts was invited to discuss his findings and research with regards to the Pylons Project proposed for Lincolnshire. He outlined his concerns of not only the infrastructure impact and potential for future industrialisation it may lead to, but also the traffic impact to Louth and the surrounding area.

After the discussion, it was decided that there were two relevant sections of the Consultation Feedback Form to have a direct impact on the Louth Area, which we wished to comment on, and to provide an overall statement at the end of the questionnaire, when asked for further considerations.

This final statement should then be sent to the relevant parties at ELDC, and LCC for their consideration also.

Route Section2 - New Grimsby West Substation to Lincolnshire Connection Substation A

Q2/Do you have any comments on Route Section 2, Including on the points listed below

There is not a preferred alignment for the overhead line.

Not since the Ice Age has the landscape of eastern Lincolnshire been so radically reshaped. The proposals will fundamentally alter the rural nature of this important Lincolnshire landscape, and will lead to a dramatic over-industrialisation of the countryside.

These proposals will radically affect the multi-million tourism offer on which our area relies and will compromise the visual amenity of the Lincolnshire Wolds, a National Landscape (Formerly AONB). This important farming area is presently not scarred by industrialisation and its clean air and big skies are popular with cyclists, and holiday makers from the industrial East Midlands in particular. Many move here on retirement for health reasons and quality of life. Fundamentally this will be wiped out by the anticipated industrialisation of the pastoral landscape.

The threat from vast Solar farms and Industry designed to utilise excess electricity produced will further erode this valuable landscape. The huge proposed centres at Woodthorpe and Beesby will dwarf our present structures and are out of character with the pattern of settlements which characterise the sub-region.

Lincolnshire has for multiple generations been the bread basket of the country with its farms, producing a third of the country's food essentials. The land supports many small farmers and producers whose very future is now under threat, severely compromising food supplies for our growing population,

Given the unstable nature of today's Geo-political environment, it is prudent to protect our farmland for crop production that provides the UK resilience should world events lead to further instability, or even the potential of escalation of war in Europe. Once lost it cannot be restored to food production.

The damage to the rich bio diversity of this well established rural environment would take many years to recover, if at all. Net gain is offered as a benefit, but all too often the rules allow for this to be anywhere within the United Kingdom, and do nothing for the community it is affecting. There are valuable bird and insect species which will be lost irreparably for future generations.

Traffic will increase dramatically in the locality, particularly during the construction phase, on roads ill-designed for a large increase in heavy traffic volume. There will be a continued need for maintenance, so this is a problem which will not go away after construction. East Lindsey itself has very few major trunk roads, and our country roads are narrow completely unsuited for the use of vehicles delivering large quantities of construction supplies and risk further erosion by this increased volume of heavy traffic. This is problematic at key times of the year when agricultural vehicles slow the flow of traffic and holidaymakers flock to the coast. There are no rail lines in this area so the community relies heavily on our poor road network for everything. Our poor infrastructure is not up to coping with this form of activity and there is no funding for upgrading this. This will lead to the potential for even more road traffic incidents, loss of air quality and increased pollution from road vehicles.

There is some understanding that the former Conoco Site in Theddlethorpe offers benefit, but the local understanding is this is to be utilised as a carbon capture facility, and there is concern that if further industry builds up here, the potential for accident increases. The Health and Safety risks have not been adequately addressed in this proposal.

Whilst there is an acceptance that the UK requires an infrastructure upgrade to hit carbon reduction targets, the solution must be off-shore development, that minimises the impact not only to the landscape but also to the very way of life that characterises the area. Over the life of this proposal the cost of putting the lines out to sea becomes more affordable and should not be viewed as a deterrent.

Alternatively, an approach that mirrors the current network that comes in at the Grimsby area, but follows the line west, toward the network that moves along the Trent river, bypassing the local farmland and National Landscape.

Q3/Do you have any comments on Route Section 3, Including on the points listed below

Our response to Q2 is all applicable to this question.

The proposed construction compound at South Reston is sited in a ribbon development village on a twisty road which is already struggling to cope with coastal traffic. The road structure in Lincolnshire east of Wragby is inadequate for the volumes of traffic National Grid is proposing and getting to Reston from Louth is characterised by stunt corners and potholed surfaces.

Tourists coming to our seaside use this road in large numbers and this is not limited to the summer as it is the route servicing the largest agglomeration of caravans in Western Europe. The caravan business should not be viewed as seasonal, it is a year-round industry.

This without doubt will ultimately lead to a loss of income for local business, and reduces the wealth of the county, already struggling with cost of living issues.

There is a concern that this large swathe of affected land will inevitably damage the valuable mixed farming in this small community.

The infrastructure equipment required for building the substations, are again requiring transportation on roads not designed for this level of traffic movement and size. We are mostly small width, winding roads, not designed for long wheel based trucks of abnormal length. The potential for incident is large and should be included on the risk register which we cannot locate in your proposals.

General Considerations

Q8/ Is there anything else you would like us to consider as we develop our proposals? Please provide details below

(PWG suggest all of the above is added to this section, and in its entirety this be presented as a statement of LTC to be given to relevant authorities).

The Impact to the Lincolnshire community is larger than what the Grid considers its impacted area. Louth itself has not been approach for direct consultation, but Louth and its residents will be impacted by this development.

Pre-1974 Louth was a Borough council, which included its surrounding villages. This in many respects represents our community much better in some respects, allowing you to understand the larger ramifications of the proposal. Villages from Wragby to Mablethorpe are serviced by Louth, being one of the larger Town Centres. Traffic flow is essential throughout the Easy Lindsey region. The traffic flow construction will generate will disrupt this community, and has direct impact on the town, even though we are offered no financial benefits to our infrastructure or community you offer the directly affected small parish councils. This would appear to be an oversight that doesn't truly reflect the impact this proposal will have to residents, businesses and the local infrastructure.

We accept that infrastructure is needed, but sensible investment that does not destroy the local environment is essential for future generations. A wholistic approach of the grid, solar farms and industry must be considered, and not a piecemeal erosion of what this county has represented for generations.

Subject: Street Lighting Improvement Scheme Louth

Good afternoon,

Thank you for your E mail regarding the upcoming lighting scheme in the Kidgate Area. It has been passed to me by my colleague for my response as Senior Lighting Engineer.

We are currently undertaking column structural testing of all our lighting columns throughout the county and this testing programme has identified the poor condition of the street lighting columns in Kidgate, Aswell Street, Lee Street and Cinder Lane. Some of these columns were identified as being structurally in a dangerous condition, and we have removed those column shafts immediately to prevent the risk of collapse.

The forthcoming scheme will replace all of the current columns and lanterns in those areas other than a small number of wall mounted units on and around Kidgate. Regarding the heritage type lanterns – we have a number of these in the county which are non-LED, this includes the Kidgate area, though I must also point out that currently neither Lee Street nor Cinder Lane currently have heritage style lanterns. We have been installing LED street lighting since 2011 as converting to LED reduces energy consumption and maintenance costs/liability moving forwards.

We simply do not have the funds available to replace all heritage lanterns like for like any longer, with the cost of a heritage lantern around eight times the cost of our maintenance lantern, or three times the cost of a contemporary alternative. I'm sure you will be aware there has been sustained pressure over many years on local government budgets, and Lincolnshire County Council's Street Lighting budget is no different. LED lanterns are more energy efficient, provide improved light level performance along with tighter light control. It is very difficult, near on impossible, to control light spill from heritage lighting and we address many complaints asking for shields or lantern bowls being painted black on heritage lanterns, negating perceived aesthetic benefits.

As an authority we have no obligation or statutory requirement to provide a particular type of street light within conservation areas. We have many conservation areas across the county with standard street lighting equipment which may be painted black and most noticeably outside Lincoln Cathedral on Eastgate there are functional street lights with black canopies. There are parts of the Louth conservation area which also have non-heritage lanterns - for instance St Marys Road, James Street, and parts of Eastgate.

We are currently in the process of replacing the heritage style lantern for a contemporary style lantern (Circa - TRT Lighting) where possible, we simply cannot afford a like for like heritage replacement. We have so far implemented this in Spilsby, Burgh Le Marsh and Bourne, where it has been well received.

It is felt that black lighting columns and the more contemporary TRT Circa lantern (as opposed to our standard maintenance LED lantern) are a reasonable compromise in certain areas - including our scheme in the Kidgate area - when compared to the unsustainable cost of the like for like replacement of decorative lighting columns and heritage. lanterns.
