Active Travel Scheme - LTC Resident, Visitor Survey Results - 783 submissions

1. With regard to the Active Travel Scheme at this current time (31/8/2022) and Café Culture do you:

- 380 Support with compromises
- 308 Totally object - Mercer Row/Cornmarket and Market Place should revert to how they were in 2019
- 58 Totally support - leave in current state

- 16 Participants ticked more than one option
- 21 Participants didn't answer the question

2. Two seating units have been put in place on Mercer Row by Lincolnshire County Council as a part of this scheme, do you think the seating should be:

- 476 Not installed at all
- 233 Installed in the Cornmarket
- 41 Installed in Mercer Row and in the Cornmarket
- 7 Installed in Mercer Row

- 9 Participants ticked more than one option
- 17 Participants didn't answer the question

- 406 All of the Cornmarket used for parking through the winter months (except for market days and special events such as Christmas Market) and Cafe Culture be encouraged through the spring and summer months
- 301 Mercer Row reverts to parking as in 2020
- 199 Cornmarket parking reverts back to parking as was in 2019 (All year except market days)
- 152 3 x 30 minute parking spaces in Mercer Row
- 128 Drop off points in Mercer Row
- 111 3 x 30 minute parking spaces (wide enough for disabled users) in Cornmarket (not on market days)

Not all participants completed this question.










